Hi Savanna, I would like to submit a question as rates have increase more then 35%.

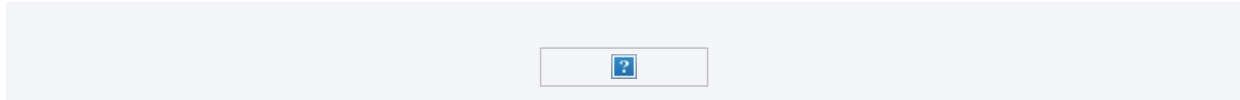
Has the commissioner thought of the impact it would have on the more vulnerable senior population as they tend to have the higher credit scores.
